The Gilford Board of Selectmen will be holding a public hearing pursuant to the provisions of RSA 41:9-a on proposed amendments to the Special Detail Fee Schedule for Police and Fire services to take effect March 1, 2023.

More specifically, the fees for public safety detail services are proposed to change as follows:

- Police details from \$70 p/h to \$65-\$85
- Fire details from \$70 p/h \$75
- Police cruiser from \$10 p/h to \$25
- Fire engine from \$95 p/h to \$100
- Ambulance from \$45 p/h to \$75
- Forestry truck from \$35 p/h to \$50
- \$10 p/h surcharge if alcohol is sold
- 20% fee reduction for gov't, school and non-profit events

Copies of the proposed fee schedule and the existing fee schedule are available at the Selectmen's Office or on line at www.gilfordnh.org. Copies will also be made available at the public hearing.

POLICE OFFICER-IN-CHARGE HOURLY FEE PER PERSON = \$85.00 (LIMIT 1 PER EVENT)

POLICE OFFICER HOURLY FEE PER PERSON = \$75.00

POLICE DISPATCH HOURLY FEE PER PERSON = \$65.00

FIRE/EMS HOURLY FEE PER PERSON = \$75.00

ADD \$10.00 HOURLY SURCHARGE PER PERSON (IF ALCOHOL IS SOLD AT VENUE)

DEDUCT 20% FOR GOVERNMENT/SCHOOL/NON-PROFIT EVENTS

MINIMUM CHARGE = 4 HOURS

CANCELLATION NOTICE = 24 HOUR MINIMUM (TO AVOID BEING BILLED)

POLICE CRUISER = \$25.00 PER HOUR

FIRE ENGINE = \$100.00 PER HOUR

AMBULANCE = \$75.00 PER HOUR

FORESTRY TRUCK = \$50.00 PER HOUR

AMBULANCE = \$45.00 PER HOUR




