The Gilford Board of Selectmen will be holding a public hearing pursuant to the provisions of RSA 41:9-a on proposed amendments to the Special Detail Fee Schedule for Police and Fire services to take effect March 1, 2022.

More specifically, the fee for special police detail services are proposed to increase from \$65 per hour to \$70 per hour and the fee for special fire details are proposed to increase from \$60 per hour to \$70 per hour. All other special detail fees will remain the same.

**Subject:** Police & Fire Special Detail Rates

---

Beginning January 1, 2022 per the Police Department Collective Bargaining Agreement all employees working a private detail will now be paid at a rate of \$55 per hour (prior rate was \$50 per hour).

The Fire Department employees currently receive \$45 per hour for a private detail.

The Public Safety Fees for Police & Fire Special Details that were effective as of March 1, 2018 are billed to the requesting company at the following rate:

Police Hourly Per Person = \$65.00

Fire Hourly Per Person = \$60.00

With the increase in the Police Department detail rate paid to employees, I wanted to reach out to the Board of Selectmen to alert them of the rate change should you would want to increase the billed amount to compensate for the increase in wages paid.

In addition, Fire Department employees are now paid \$10 less per hour for a special detail than that of Police Officers, and I wanted to alert you on this as well, should you want to increase the Fire Special Detail wage to be more in-line with the Police Department. In speaking with Fire Chief Carrier, the Fire Department has always tried to keep their detail fees at a reasonable rate and have been slightly lower than the Police Department, however, he would be in support of bringing his staff up to the same detail rate of pay as the Police Department.

I have also included a copy of the 2018 approved Public Safety Fees; Police & Fire Special Details for reference.
