The Gilford Board of Selectmen will be holding a public hearing pursuant to the provisions of RSA 41:9-a on proposed changes to the Ambulance Service Fee Schedule as approved by the Board of Fire Engineers. If adopted by the Selectmen, the new fees are scheduled to take effect as of January 1, 2023. The last times fees were increased was April 1, 2018.




