General Notice

Town of Gilford, NH (Owner) is requesting Bids for the construction of the following Project:

Governor's Island Bridge – Expansion Joint Rehabilitation

Sealed Bids for the construction of the Project will be received at the Town of Gilford, at the office of the Public Works Department, 55 Cherry Valley Road, Gilford, New Hampshire 03249, until **4:00 PM** local time on, **Tuesday, February 1, 2022.** At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Partial demolition and removal of two (2) existing expansion joints (partial asphalt overlay removal, concrete deck ends removal, top of concrete backwall removal, headers and compression seal removal). Construction of new expansion joint elements (deck end reconstruction, backwall reconstruction, new headers and compression seals, asphalt paving). Preparation, cleaning and painting of steel stringer ends and bearings.

Bids are requested for the following Contract:

Governor's Island Bridge – Expansion Joint Rehabilitation

Owner anticipates that the Project's total bid price will be approximately between \$300,000.00 and \$350,000.00. The Project has an expected duration of 120 days.
