BUDGET COMMITTEE  
MEETING MINUTES  
April 26, 2018  
7:00 PM

Members present: Sean Murphy, Richard Grenier, David "Skip" Murphy, Chris McDonough, Susan Greene, Joseph Wernig, Kristin Snow, Timothy Sullivan, S. Peter Karagianis, Jack Kelley, Tracie Corbett and Thomas Chase.

Skip Murphy called the Budget Committee meeting to order at 7:00 pm and led the assembly with the Pledge of Allegiance. Mr. Murphy took a roll call of members present for attendance.

Approval of minutes:

Skip Murphy explained there are only three members that were present at the 03/12/18 meeting that could vote to approve the minutes. Susan Greene made a motion to accept the 03/12/18 minutes as written, seconded by Chris McDonough and passed; (3-0). (Voting members were S. Greene, C. McDonough and Skip Murphy).

Resolution regarding review of expenditures:

Skip Murphy explained for the new budget committee members, that at the 03/12/18 meeting, a vote took place to accept a Resolution regarding budget expenditures and review by the Budget Committee. He also expressed his desire on the format of how the information is submitted from Town and School Officials. Mr. Murphy said in his opinion, the Budget Committee should meet with Town and School officials monthly to review their budgets. Discussion ensued. Chris McDonough stated that the Town and School both have qualified elected officials that review regularly and that it may be more appropriate to have the Budget committee have quarterly meetings to review; that is sufficient. Tom Chase agreed with this. Discussions ensued.

Committee Assignments:

Skip Murphy distributed signup sheets for sub committees for both the Town and School, asked that there be three or more members to each committee. He explained for new members, the process of sub committees and their role in the budget process.

Elections: Skip Murphy said the committee needs to vote for a Chairman and Vice Chairman of the Budget Committee. Chris McDonough made a motion that the committee hears all of the nominations for each position, before the vote on that position; seconded by Joe Wernig and passed; (10-1-1) Skip Murphy voted no and Timothy Sullivan abstained.

Chris McDonough made a motion to nominate Sean Murphy as Chair; seconded by Joe Wernig. Timothy Sullivan made a motion to nominate Skip Murphy as the Chair; seconded by Peter Karagianis.

Sue Greene made a motion to nominate Peter Karagianis for Vice Chair; seconded by Timothy Sullivan. Joe Wernig made a motion to nominate Tom Chase as Vice Chair; seconded by Tracie Corbett. There were no further motions made for nominations.

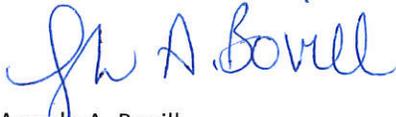
Vote of Chair: Chris McDonough made a motion to vote for Sean Murphy as Chair; seconded by Joe Wernig and passed.
