


UNFRAGMENTED LANDS MAP

SCALE: 1" = 5000'



**Unfragmented Lands Map**

The Unfragmented Lands Map shows the location and size of unfragmented blocks of land in Gilford.

Unfragmented open space blocks are undeveloped sections of the landscape with few or no roads. These blocks are unrelated to parcel or ownership boundaries. Unfragmented blocks are of high significance to wildlife and identify large areas of open space.

Unfragmented blocks include Class V and Class VI roads because these types of roads aren't considered significant barriers to wildlife (and many of them can be regarded as trails).

**Analysis of Unfragmented Land Blocks**

The unfragmented lands displayed in this map were derived by creating areas bounded by buffers that were set 500 feet from the centerline of maintained roads.

Unfragmented blocks that extend beyond the townline may have substantially greater areas than indicated on the map. Because of this, blocks which extend beyond the townline were calculated in the acreage, indicated in the legend.

These blocks are extremely important, worthy of additional protection, study, or cooperative planning with the communities that share these blocks.

**Data**

Besides data from the Base Map, this map contains the following: Unfragmented Land Block and road class information was derived by using NH GRANIT Data.
