A motion was made by Ralph Federspiel that Mr. Spead act as moderator Pro-Tem. The motion was seconded by Joe Dietrich and Mr. Spead moderated the business of electing officers.

A motion was made by Jane Spead to have Carol Martine as clerk. The motion was seconded by Clifford Wylie and voted on by the body.

A motion was made by Mrs. Hett for Dominic Bodolato to be treasurer. The motion was seconded and voted on by the body.

Nominations opened for 3 commissioners. Richard Spead, Carolyn Parker, Frank Hett, and Gerauld Allen were nominated and seconded.

It was decided that the body would vote by written ballot for the election of 3 out of 4 of the nominees. Supervisor of the check-list, Sue Harris, officially counted ballots.

The results were:

The motion was made, seconded, and voted on by the body, that the annual meeting of the Gunstock Acres Village Water District be held "on the first Saturday after the annual town meeting".
