**1. ATTENDANCE**

**Call meeting to order:**

The meeting was called to order by J. Goodhue at 7:07 p.m.

**Approval of Agenda:**

**2. APPLICATIONS:**

1. **Standard Dredge & Fill Application, Rabuck Revocable Trust, Paul Rabuck Trustee Gilford Tax Map & Lot #267-170.000 located at 46 Dinsmoor Point Rd.**

Applicant proposes to replenish 10 cubic yards of beach sand, replace 3 rocks that have fallen from breakwater and allow an after the fact gazebo 10' x 10' located at 46 Dinsmoor Point Rd. Gilford NH.

**Discussion:** C. Hall reviewed the application and noted the gazebo was not shown in pictures submitted with application and abutters were not notified of request for an after-the-fact permit for the gazebo. Commissioners noted the gazebo could not be located within the first 50' from the shoreline according to the NH Shoreland Protection Act.
